A \$50 check is required to hold your spot. We do expect to sell out this year, so we recommend reserving your spot early. You may choose to pay in full at the time of registration or in two equal installments, the last of which must be received by April 30, 2013. MEMBER AGREEMENT:

I agree to pick up produce at the agreed upon place and time. If produce is not picked up within the stated time limits and prior arrangements have not been made, I understand that week's share will be forfeit.

I will make prior arrangements for vacation dates at least one week in advance. I understand that the farmers reserve the right, based on availability, to determine the possibility for make-up dates. I may also make arrangements for a friend to pick up my share in my absence.

If I opt for on-farm pickup, I agree to respect the property and livestock of the farmer. I will not bring dogs to the farms, and if I bring children, they will be supervised. I will park in designated areas. I understand that membership does not entitle me to visit the farm unannounced.

I understand that variety of produce received depends on growing conditions that vary from season to season and that the risks and benefits of the harvest are shared.
